<b>Location</b>	Predominantly based in Northfleet however various locations as required to fulfil the role.
<b>Working pattern and Work base</b>	6 hours per week You will be required to work evenings during the week and weekends.
<b>Summary</b>	<p>The Position is a part-time position and will be responsible for providing medical coverage for the Women's First Team.</p> <p>The Women's Sports Therapist will assess, diagnose and treat player injuries.</p> <p>This Position requires flexibility and a willingness to work non-standard hours in accordance with the needs of the Club. The successful candidate will be required at home fixtures along with travelling to away fixtures with the First Team.</p> <p>You must be adaptable and able to quickly adjust to the requirements of the role, also forming positive relationships with other team members and demonstrating commitment to the Club's ambitions.</p>
<b>Objective of the role</b>	<p>As the Women's Sports Therapist, you will be responsible for:</p> <ul style="list-style-type: none"> <li>• Attending all training sessions and games during pre-season and normal season;</li> <li>• Medical screenings for the current squad;</li> <li>• Soft tissue management and treatment as part of pre-training and pre-match preparation (such as strapping and massage) as well as other modalities;</li> <li>• Assessing and treating injuries which occur during training sessions and matches;</li> <li>• Managing injured players through their rehabilitation and return to play programs;</li> <li>• Keeping current and accurate medical notes; and</li> <li>• Maintaining a regular and current CPD portfolio.</li> </ul>
